We ask that you remain patient and recognize that the time delay represents not a lapse in our efforts or dedication, but rather is a reflection of our unwavering commitment to ensuring a fair Collective Agreement for NASA.

We look forward to resuming our sessions with the NAIT's Bargaining Team later this month to continue negotiating in good faith and will provide a more comprehensive update to all of you after our first meeting. Just a reminder that our current Collective Agreement remains in effect until a new one is ratified by members.
